Profit tax

Not paid from the sale of goods of own production for export or to other residents of the FEZ

Real estate tax

Not paid on the objects within the territory of "Mogilev" FEZ

Rent payment for land plots (land tax)

Not paid on the land plots within the territory of "Mogilev" FEZ

Customs preferences

Exemption from customs duties on raw materials and equipment imported to the territory of Free Custom Zone (FCZ defined for each resident individually)

Exemption from customs duties on manufactured products being exported outside the Eurasian Economic Union
